### 1.1 Bidder

The bidder is the company which is designing, manufacturing and supplying majority of the value of the tender. The same bidder would be the purchaser of the tender document and GARC would interact only with this bidder in terms of entertaining him for tender document clarifications, evaluating him and considering him for selection, award of contract and the subsequent execution of the contract.

In case the bidder authorizes his representative to interact with GARC, such a representative will not be a part of contract agreement and financial dealing with GARC.

A bidder cannot submit more than one bid.

## 1.1 **Bidder's Experience**

Bidder should have a minimum of 3 years of experience in the business pertaining to the equipment mentioned in this tender document. The bidder shall submit a proof of such a business. This information shall be provided in "Form d5) Bidder's Organization, Company Profile and Sub-contractors". Indian experience should also be clearly spelled out by the bidder in such a document.

Further Bidder is also required to provide details of projects wherein the bidder has supplied equipment/s as mentioned in Clause no.1 "Annexure-1 Scope of Supply" during last three years.. Bidder is requested to provide a full list of such projects in "Form d3) References".

Further, Bidder shall have successfully designed, supplied and installed at least Seven(7) facilities in India and at least Fifteen(15) facilities in the world for equipment/s as mentioned in Clause no.1 "Annexure-1 Scope of Supply" in last three years. Bidders are required to provide in " Form d3) References" the full details of such references in "Form d3) References".

#### **1.2 Specific References**

The Bidder / Technical Partner is required to provide at least one reference on the following specific requirements, to be included in "Form d3) References". For each one of them, the Bidder shall fill a proforma, clearly stating the values achieved for each requirement the reference refers to. Each proforma shall hence reproduce the requirements which are under its scope, with the particular result achieved in the given reference.

## 1.3 Bidder's Organization and Company Profile

Bidder is required to provide the information about him as per "Form d5 – Bidder's Organization, Company Profile and Sub Contractors".

Bidder shall have sufficient financial strength in order to undertake the assignment. Average annual turnover over the last three years shall be higher than INR 7 crores.
